Kansas vs Missouri - Destry Brown, Superintendent in Clinton, Missouri - compared his experiences in Kansas and Missouri in the areas of budget, finance, expected carry over, retirement, and educational programs.

Update from the commissioner - Randy Watson, KSDE - Shared the latest ACT results for Kansas – he shared the following:

- Composite score is slightly down, but so is the national average.
- Kansas increased its participation by 22% this year or 1136 students.
- 82% of Kansas students met SAT benchmarks for college readiness.
- Kansas has third highest standards in the country.
- Math we are spot on.
- Percent of kids scoring college ready in all areas the same as last year.
- Working on a different look for testing In the past an ACT of 18 or above indicated a 50% chance of a student receiving an A or B in English Comp 1 in college.
- In the future KSDE plan will focus on realigning. (See PowerPoint slides)

- Average salary of teachers Kansas teachers rank 40th in the nation on salary. With hopes of restored funding, do our teachers deserve better? Possibly get this to the median? (pgs.28a-28b)

Kansas Mental Health Pilot program update:

- School liaisons from Abilene, Herrington, Chapman, and KCK shared the need for more therapists and increased communication between agency and schools.
- The pilot program was approved by the Kansas Legislature to team up schools and community mental health centers to treat some the states most at risk children.
- The pilot program set aside \$10 million to treat and track two preselected groups of children and six districts across Kansas.
